## **Alabama State Port Authority Announces New Service CG Railway Resumes Rail Shipments Between Mobile & Coatzacoalcos, Mexico**

**Mobile, Ala. - June 27, 2006 (2:00 p.m. CDT.)** The Alabama State Port Authority has approved an agreement with International Shipholding Corporation to develop a new rail ferry terminal at the Port of Mobile. The proposed terminal, which will dock CG Railway's ships, will be located on the main port complex just north of the Authority's Pier E terminal on the Mobile River.

Governor Bob Riley of Alabama announced the new service earlier today and praised the project as key to Alabama's continued economic growth. "We're going to begin this project immediately because it's important to the continued growth of our port and the continued growth of Alabama's economy," Riley said.

The Authority's Board of Directors approved the estimated \$19 million dollar project following Governor Riley's announcement that International Shipholding Corporation would locate its corporate headquarters to Mobile, bringing an estimated 150 jobs. Construction on the new terminal begins immediately with first vessel call expected in early 2007. The Authority's Terminal Railway division will handle the loading and unloading of rail cars to CG Railway's ships.

"Mobile and the CG Railway service are the perfect fit," said James K. Lyons, Director and CEO of the Alabama State Port Authority. "The company plans to double the capacity of its ships and the Port's regional cargoes can fill that capacity. We've known the company and her employees for many years and we are proud to welcome them to our port community."

The new rail ferry terminal will be the first of its kind with a twin deck design that will have the ability to load two ship decks via four ramps to the lower deck and six ramps to the upper deck. The cut-in slip will measure about 400 feet in length and will have about 4000 feet of rail track laid behind the slip. The design will encapsulate International Shipholding's vessels. The company is currently modifying its vessels, THE BALI SEA and THE BANDA SEA, by installing second decks to increase ship capacity to 122 standard rail cars. Currently, these ships can haul 60 standard rail cars per voyage.

The service when operational will provide 4-day rail service between Mobile and Coatzacoalcos, Mexico.
